The Werribee River Association Inc. (WRA), established in 1981, is a not-for-profit waterway protector whose purpose is to work to protect the natural environment and promote sustainable living practices.

Our history is rooted in advocacy and volunteering for the environment and human health within the Werribee River catchment. The former Committee of Management is now a Board of Management, and we have paid staff leading the work, supported by community volunteers.

The organisation is guided by a Strategic Plan 2019 – 2024, a Business Plan 2021-2025 and has completed a Concept Proposal for a Community Enviro-Hub as a valuable future environmental asset for the West which supports our vision of a secure and permanent place of our own.

Werribee River Association staff and board acknowledge and respect the Traditional Owners of the land and waterways upon which we work, live and play, in particular the Wadawurrung, Bunurong and Wurundjeri people of the Kulin Nation.

We acknowledge and respect Elders past, present and emerging. Sovereignty was never ceded, and we firmly believe that First Nations people deserve recognition in the Australian constitution.

Our Chair's report

It has been an honour to serve as the Chairperson for the Werribee River Association this reporting period of July 2022 to June 2023, the 42nd year for the Association. I have been on the board since 2017 and so lucky to witness our progress and development as well as our ongoing impact.

Since 1981 the Association has been working toward a healthy Werribee River catchment. Our organisation works with land and water managers and the local community to support and restore biodiversity; to support improved water quality outcomes for the river; to deliver environmental education and to draw focus to the iconic Perridak (platypus) that calls our river home. The Association invests in programs that build community connection and strength and our activities and areas of focus are shaped by global, regional and local environmental needs.

For many years, John Forrester, our much loved and respected River Keeper has been a strong and consistent voice for the river and our community. John has continued this advocacy over the past year, has continued to educate us, and has shaped our work and the drive for professionalisation across our organisation.

Our dedicated Business and Community Development Manager, Lisa Field, has continued to guide the team to deliver a great range of community environmental programs, in the field, in the classroom, involving Traditional Owners, targeting diverse communities, using the arts and promoting advocacy and direct action. We truly have a dedicated and passionate team who work above and beyond expectations to keep achieving great outcomes.

We are grateful for the support of our funders and partners and for the opportunities to collaborate with all our stakeholders. Our programs are aligned to local, state and semigovernment policies and working group objectives and we are proud of our contribution towards Wyndham City's Resilient Wyndham 2020-25, Melbourne Water's Healthy Waterways Strategy 2018-28, the Waterways of the West Action Plan, the Lower Werribee Waterway Amenity Action Plan, the Central Region and Gippsland Sustainable Water Strategy, and the Port Phillip and Western Port Regional Catchment Strategy.

Over the past year, we've revisited and celebrated our proud history as an organisation, and the achievements of every dedicated member and volunteer over 42 years of action. Through our work to develop the Werribee River Guide, we've highlighted our amazing Wirribi Yaluk and its surrounding environs and helped to elevate our amazing natural heritage to greater prominence.

Organisationally, we've experienced significant change this year with the departure of three of our volunteer board members, and we've welcomed four new members into the fold.

We are measuring our progress and impact against the objectives we set ourselves in our 2019 – 2024 Strategic Plan, and we're preparing the groundwork required for our next plan. We've been reviewing our capacity, our strengths and areas to be further developed so we can continue to have far reaching positive impact.

I would like to thank the full contingent of board members who have helped us on our journey of improved governance over the last year, with special thanks again to Rob Bradley for being a terrific Vice Chairperson and always having WRA, our members and our mission front of mind. We manage our finances astutely and are grateful for the funding support from Melbourne Water, Wyndham City Council and DEECA, and we are proud of further funding diversification achieved this year through Lisa's hard work and initiative. Werribee Riverkeeper's *Report*



The Minister for Water, Harriet Shing MP launched the Waterways of the West CALD Toolkit for practitioners, with various community, government and Traditional Owner stakeholders in Werribee.

As I move through my 30th year with the Association, I can reflect on a lot of changes in the Werribee Catchment, the Werribee River and other waterways, and well as various improvements within our organisation which have been necessitated by those changes.

When the Association commenced in 1981, there was no waterway manager, and local residents in the township of Werribee were very alarmed at the disregard for the Werribee River. WRA realised very early that the Werribee River is a living entity, deserving a rightful entitlement of environmental water flows to survive.

Now all of our river systems are being seen as natural entities, as decreed by the State of Victoria in the innovative Waterways of the West legislation 2021. That legislation came about because of our community advocacy, emphasising the waterways as valuable community and natural assets, essential for all life. WRA and our allied groups wanted change in the way in which our waterways were respected and valued as living entities.

Advocacy Improving amenities, access, water quality

When the Association formed in 1981 letter writing was the way things were done, but today methods and outcomes of advocacy have expanded significantly. From formal submissions, to advocacy walks, to meeting with Members of Parliament, our advocacy pitch has been varied, proactive and efficient, and promotes the wider benefits of a clean environment for all.

To achieve such change, WRA partnered with an alliance of community and environmental organisations and individuals working for long-term sustainable water options for the people of Victoria, the health of the Werribee River, and the cultural, economic, environmental and social values it provides for the Werribee Catchment.

Our growing number of strategic alliances now exceeds sixty, and covers business, community groups, universities and more. A significant part of our work toward change is working within networks and forming partnerships. The theme of this work includes: reducing stormwater

pollution run-off, mitigating poor urban design that has impacted on wetlands; improving biodiversity outcomes along the riverine parklands; protection of green wedges; enhancing plantings in public spaces; allowing community plantings in new estates; and, planting trees for shade, habitat and aesthetics.

Our team have engaged 88 campaigns, submissions, collaborative actions and meetings involving 768 people across our partnerships, and reaching countless others via social media, television, radio and the press.

Our work is not finished. We need to continue work on the threats imposed on our waterways and human health, and engaging with organisations which impact our waterways. That includes water authorities, municipalities and their planning, open space and other teams, the EPA, Parks Victoria and more, including those organisations whose work while not responsible for water or waterways, nonetheless impacts them such as VicRoads and housing developers.

PROJECT HIGHLIGHTS

Concerned Water Alliance

Fortnightly meetings with a group of waterway and Landcare leaders was instrumental in reporting to government the true value of water. In the lead up to the October 2022 State Election, our team visited 19 politicians to provide our recommendations for future water security and pollution controls.

Advocacy Walks

The simple act of bringing stakeholders together is instrumental to better management of land and waterways. This past year we have held stakeholder walks along the lower Werribee River, behind the farms, to support better information and collaborations across different land managers, and also to highlight the care which the official land manager DEECA, finds it hard to achieve.

The Association has been working in partnership with diverse stakeholders since 1981 – underpinning much our work is speaking up on matters that concern community.

Our team have also been engaged to support to enhance community engagement into government consultations, with our expertise at the local level being of notable benefit.

Werribee River Guide

The new Werribee River Guide launched in June 2023 is a website and printed brochure that stems from a collaborative partnership, working to enhance the lower Werribee River. This Werribee River Guide speaks up for the river in a new voice, and is not your typical tourism guide.

The website www.werribeeriverguide.com seeks to showcase the special places and hidden gems along the river. Whether planning a family day out, or looking to get on the move along the trails, the guide is a resource to explore.

The Lower Werribee Waterway Amenity Action Plan (LWWAAP) Implementation Group

Following the development of the LWWAAP in 2021-22, a group of stakeholders continue to meet to support the actions identified in the plan. The LWWAAP is an action from the Waterways of the West Action Plan, released by the Victorian Government in December 2021, which highlights the importance of waterway amenity for the west's growing population.

The actions in the plan are wide and varied, listing the many needs of the lower Werribee, and providing direction for those government and other organisations which can do so much to provide a better community access and amenity, and a healthier waterway.



Education – developing a love for nature

The Werribee River Association's educational services play a crucial role in promoting waterway health and environmental awareness among our target audiences that include children, adults, and our culturally and linguistically diverse community. Our educational services aim to be inclusive, adaptable, and in both traditional presentation methods and hands-on experiences like field trips, to support a well-rounded learning experience for students.

Working within the traditional schools environment, whom typically have a very busy schedule, has been slow in Terms 1 and 4, but there was a higher uptake of our services during Terms 2 and 3, which is pleasing.

Our aim is to continue to broaden our work with schools and learning providers, and it is pleasing that we now have a partnership with Wyndham City that supports our school sessions on biodiversity outcomes. This reduces the financial cost on schools, and is an enabler for the growth of our reputation and experience working in Wyndham's schools.

Wyndham City and Melton City have engaged us for school holiday programs, and we have also developed our own series of school holiday programming to meet the needs of a young population.

In partnership with the Port Phillip Eco-Centre we co-led educational programming with students at Wyndham Community Education Centre, on a project to build multicultural ambassadors for the environment.

To reach a younger audience, our team have needed to refine, develop and explore what we do. We've used storytelling, music, creativity workshops, outreach events, and partnered with schools and other services to develop effective and engaging programs.



Our environmental educational programming for the young age groups, has included everything from traditional classroom presentations on wildlife, to nature play and bush crafts, to looking at water bugs under the microscope, to picking up litter, and some session designed for specific audiences, i.e. youth leaders. We have also led guided walks at various locations with families, Scouts groups and schools.

Within our programs for younger audiences, we provided more than 60 sessions, to 2600 attendees.

PROJECT HIGHLIGHTS

CALD Engagement Program

A new CALD engagement project commenced in September 2022, funded by DELWP (now DEECA). This 22-month CALD Engagement Program provides varied programming initiatives for children, and families, particularly school holiday programming and activity resources for children. We also attend festivals and community events, lead guided walks and conduct healthy soils workshops as part of our work with diverse communities.



We delivered 60 educational programs for children and youth engaging 2600 young learners.

Community Engagement

Enabling a rich & diverse place for growth

This year our community engagements have grown significantly. We have achieved this through collaborations with partner agencies, by engaging many new casual and culturally diverse workshop instructors, and by experimenting. We can't do this work alone, and it has been wonderful to expand our net of facilitators, supporters and attendees. Our community engagement activities have also been enhanced by using the arts as a medium to communicate our values and connections to waterways.

Community engagement with the Werribee River Association includes all of our guided walks, presentations, workshops, paddle and fishing events, food and other swaps, stalls, potluck dinners and other social events. This year we have delivered almost 140 community engagement events to over 8000 attendees.

Our focus through all of our work is on building community awareness on the importance on protecting our environment, water literacy, biodiversity and nature awareness; however, we have also focus on sustainable living practices, the share economy, social development, place making, and community capacity building activities.

With our larger and broader plans to one day have our own place, a community environmental hub, it is important we keep expanding our services that will one day, neatly fit into this mould. And won't that be wonderful.

To reach a broad community base, our team attended the Wyndham City's Children Week Picnic and Winter Street Party, and Melton City's Djerriwarrh Festival. We also hosted music in the park, toy swaps, and included cultural foods into the programming.

It is at many of these events we get to show off Peri, the taxidermy platypus, and our expanding team of non-living display animals, like Coco, the very popular paper-mache frog.

None of this work is possible without the support of our funding providers, community partners, staff and volunteers. It has been a significant year of growth, and no doubt a great platform as we continue to move about the catchment.

PROJECT HIGHLIGHTS

Mothers for Mother Nature

Mothers for Mother Nature was a monthly program of activities to engage culturally and linguistically diverse (CALD) women in the environment/sustainability space in Wyndham. It connected locals with each other and with the Werribee River Association.

Overall, the program met its objectives, to create opportunities to link culture, nature and sustainability; to facilitate a sense of stewardship over waterways and landscape; to broaden overall community appreciation of cross-cultural values related to responsibility for nature; and, and to foster future diverse leadership in the local environment space.

Sustainability Street

The project's deliverables were modelled off Wyndham City Council's Resilient Wyndham, an important strategy to address the social and environmental impacts of the pandemic and climate change. In 2022-2023, Sustainability Streets engaged over 4000 people in 56 events.

Highlights include the development of an ongoing intergenerational nature playgroup, a new volunteer litter group for Point Cook, the implementation of 10 street libraries throughout Wyndham and inevitably new friends and supporters. Through widespread media coverage of the events, the project also helped to elevate the exposure of the organisation.

Paddle the Werribee River

We arranged 3 paddle days from Riverbend Historical Park, in partnership with Paddle Victoria, that enabled 120 people to experience the Werribee River up to Davis Creek

Catch a Carp at Manor Lake

This highly successful event highlighted this invasive species, and partnered with Victorian Fisheries Authority, Women in Recreational Fishing Network, fishing legend Jo Starling, Hooked On Bait and Tackle local business, Wyndham Council, and Melbourne Water.



Regeneration

From drought to floods, a year of change

WRA's regeneration programs are reaching great outputs, partnering with community, business and land managers, and lead by our dedicated Regeneration Officer.

Across 56 events, we also had 524 volunteer engagements, working 1264 hours to support these conservation efforts. Our largest planting target was reached this year, with over 20,000 trees, shrubs and groundcovers being planted.

Over the following years, these small tube stock plants will offer a significant benefit to the local ecosystem, in and around the Werribee River, and ultimately support human health.

Some of our larger projects have included the planting of 5000 plants at Werribee River Park, part of the More Trees for a Cooler Greener West funded by the Department of Energy, Environment and Climate Action DEECA, formerly DELWP.

In September and October 2022, the Werribee River flooded in and around our planting area at Werribee River Park. It was really a beautiful sight with the flood plains covered in water. Our

plantings were not so negatively impacted by the flood waters; however, the waters did affect road access and led to the closure of the pedestrian bridge over to Werribee park precinct. This made our work all the more difficult.

It was pleasing to sign a partnership MOU with Wyndham City, strengthening our relationship and work across key sites within the municipality.

PROJECT HIGHLIGHTS

Friends of Cobbledicks Ford

Now in its 5th year, this partnership program with Wyndham City has included monthly conservation activities in the reserve, between March and October, engaging a community of environmental stewards and supporters to help build this beautiful spot along the Werribee River. Co-led by volunteer John Marks and Jo Cumbo, with regular assistance from the team at Dreambuilders Centre for Change.

Friends of Presidents Park

One of our newer regeneration programs, conducted on the 1st Thursday of the month is still taking shape, but has been achieving amazing work supported by the team at Dreambuilders Centre for Change. As such, we have needed to broadened our reach beyond Presidents Park and to the surrounding areas. For those wanting to get a bit more active and outdoors, local in Werribee, this is the program to join, and we are looking for leaders and more regular community volunteers to support.

Partnership wins an award

The Werribee River Association are extremely pleased with the long-standing corporate partnership with Holcim Quarry. Together we have tracked some amazing results, that now includes almost 25,000 plants in the ground, and 5 tonnes of litter removed. Plus, we've shared many a good BBQ put on by Graeme Jones and his team after a morning out in the field.

In February 2023, at Holcim's Annual Awards held in New Zealand, this partnership was recognised, winning the Community Award – The Holcim Spirit, and acknowledging the strong relationship with the Werribee River Association that has been in place for over 10 years.

Save Our Soils

This multi-year project will monitor stormwater and agricultural run-off in two locations in Werribee South, to better understand the quality of water entering the Werribee River and Port Phillip Bay. The data will inform long-term evaluation of nature-based interventions in managing run-off.

The project includes community engagement, citizen science, real-time data monitoring, conservation plantings, advocacy and strategic partnerships to support the water quality of the lower Werribee River.

Werribee Park Golf Club Werribee Blue Box

WRA were extremely excited to receive a Melbourne Water grant to plant a biodiversity bed underneath the large, remnant Werribee Blue Box located on the river at the Werribee Park Golf Club. The project which involved planting 1,000 grasses, groundcovers and wildflowers, along with mulching, will assist in attracting beneficial insects, water retention, increasing organic matter and improving soil health, ensuring the ongoing health of this beautiful tree.



20,000 plants were added to the catchment along the riverine parkland. This was our largest planting season ever, supported by partnerships, volunteers, donors and government funded programs.



Citizen Science - measure to protect



Birds, frogs, platypus and water quality parameters were just some of the areas of investigation within our citizen science programming this year. Across 81 events, 345 attendees and 715 volunteer hours, volunteers were able to learn through direct measurement, and scientific exploration.

PROJECT HIGHLIGHTS

Frog Engagement & Protection Project

This project was led by Erin Bradley, local environmentalist, and long-term member of the Werribee River Association. Over 50 nights, 61 volunteers participated in the surveys that confirmed that several frog species were present in Wyndham waterways. 561 frogs were visually detected and of the native species detected, they included 1 Striped Marsh Frog, 80 Common Eastern Froglets, 103 Growling Grass Frogs, 137 Eastern Banjo Frogs (Pobblebonk), 240 Spotted Marsh Frogs. With special mention to the detection of 255 frogs within Graham's Wetland Reserve, including 53 Growling Grass Frogs (and even more heard). Erin also visited schools and attended community stalls. The full report is on the WRA website.

Waterwatch Werribee

Since 2008 The Werribee River Association has been undertaking monthly water quality testing at Bungees Hole as part of Melbourne Water's *Waterwatch* program. The program asks local volunteers and community groups to collect water samples to test for salinity, nitrates, phosphates, pH levels and turbidity.

With 15 years' worth of data collected at the site, we now have extensive insight into the characteristics of the area, the common threats and priority areas for advocacy.

This work is open to participants to drop by and see how the testing occurs and learn first-hand about water testing in the Werribee River.

Waterwatch expands to Werribee South

In 2022 we expanded our collection site into the lower Werribee River, to include three drain outlets in Werribee South. Aware of the important contribution Werribee South's market gardens make to Melbourne's food security, as well as the challenges many of the farms are facing in the current climate, we believe that this testing can help contribute to more economically viable and sustainable farming in the area.

Findings from four monthly tests from Nov 2022 to Mar 2023 reveal that sediment is coming off the farms, but not on a regular basis. It seems to occur after rain, irrigation or a combination of those two. Sediment runoff is not desirable for waterways or the farms as it means topsoil, and the nutrients it carries with it, is washing into the river. The Werribee River Association will be undertaking extensive planting around more than one of the selected drain outlets later in 2023 and will monitor whether this reduces sediment run-off.

This work is part of a project called Save Our Soils, funded by DEECA.

Litter Blitz - community champions act for everyone

Joining a litter clean-up group is as simple as showing up. Informal, direct action, and open to diverse ages, language groups and abilities.

This year we had 5 formal groups undertake 48 community clean-up events, working alongside 84 individual clean-ups, all recorded via the Litter Stopper App, amassing to 4.5 tons of litter removed. Areas covered in Werribee, Wyndham Vale, Manor Lakes, Tarneit, Hoppers Crossing, Truganina, Point Cook and Werribee South. A total of 695 volunteer engagements worked 873 hours to achieve this valuable work.

The first community clean up group was Beach Patrol 3030 that commenced in 2015, followed by Love Our Street 3030 in Werribee in 2018, Love Our Street 3029 in 2019, Love Our Street 3024 in 2020/21, and then the newest of the groups, Love Our Street 3030 – Point Cook, commenced in September 2022.

This group came about due to interest within the community particularly from the Korean Seniors Group in Point Cook.

The Association also arranges one-off clean-ups for students, community & corporate groups and in response to environmental hazards that required action.

In late 2022, we discovered a bean bag type toy and its polystyrene contents had been dropped into the Werribee River in central Werribee. We attempted to clean what we could and lodged a report with Melbourne Water seeking support. Also in late 2022, a volunteer alerted us to 30+ large polystyrene building pods in the dry river beds in the Werribee River. Together with Wyndham City cleansing crew, we removed these.

Our Facebook account that commenced in 2011, now has 5.4K Followers, and Instagram 1.2K followers; with an estimate reach of 200,000+.

The Association is supported by multiple newsletter subscriptions. The main email newsletter is sent out monthly, with over 2,000 subscribers, and 5-6 smaller email subscriptions for each litter and Landcare program.

We appreciate the number of people and organisations that share our newsletter – adding to the overall reach that we estimate to be 30,000+.

Our other online accounts include LinkedIn and Eventbrite; however, we have shifted our focus very much toward our updated website. If you haven't been, please check it out.

32 articles or appearances in the media supported our work.

Across all communication channels we estimate our reach is 250,000+

Our former website was not attracting any traffic, and was rarely updated, unlike our new website, that is routinely updated with new content.

The newly branded website launched in May has much better functionality, and includes all of our events, reports, a blog spot etc.

Our Financial Reports

The Werribee River Association has continued to operate as a professional not-for profit business across 2022-23 financial year.

The sound financial management of the business operations has been overseen by our board, Treasurer, and a Finance Sub-Committee.

The day-to-day financial operations is supported by Bookit Bookkeeping, and our annual audit provided by Collins & Co, an independent auditor based in Footscray, Melbourne. The following pages here are from the financial audit.

Our Business & Operations Manager also supports the Association's smooth financial management.

Financial assets for the Association are just over \$700,000, with over \$150,000 being set aside for investment and further capacity building.

The income sources for the Association are largely coming from government grants, that set the terms and conditions that are often one-off and short term.

Some of our grant funding is multi-year, like with a Bayfund Project funded by DEECA; and from Melbourne Water; this presenting a welcomed degree of certainty.

Corporate sponsorships can also be reoccurring and a reliable source of funds to assist operations of the organisation, and this area of our finances has been steadily growing.

It has been pleasing to be part of the More Trees for a Cooler Greener West program. Whilst this provided significant work for the delivery, it also supported our current staffing of the Regeneration Officer. There is a growth in the funding from corporate support programs, donations, and program fees. A very small amount of funding is generated by investment interest and membership fees.

Our total income for the 2022-23 FY was \$568,630.08.

The major expense for the Association is toward staffing and professional services. This expense is aligned to the delivery of the funded programming, the management, and in the delivery of fee for service work.

It is consistent that a community environmental agency's major expense is on its people, given the nature of the work is across education, community engagement, regeneration, advocacy etc.

Other expenses for the Association include the indigenous plants we use, regeneration equipment and supplies, printing of materials, vehicle expenses and general program expenses.

We do have unfunded expenses, i.e. website hosting and maintenance, members portal, rent, etc, we continue to keep these costs down. This year we did invest in a website refresh, supporting all of our programming, particularly engagement, advocacy and communications.

The total expenses for the 2022-23 FY were \$467,609.37.

A net profit of \$101,020.71 was earned.

Thank-you to our funding providers, sponsors, donors and diverse supporters, and to the staff and contractors we engage to deliver great value.

Notes to the Financial Statements

Werribee River Association Inc. For the year ended 30 June 2023

1. Summary of Significant Accounting Policies

The directors' have prepared the financial statements on the basis that the company is a non-reporting entity because there are no users dependent on general purpose financial reports. This financial report is therefore a special purpose financial report that has been prepared in order to meet the needs of members.

The financial report has been prepared in accordance with the significant accounting policies disclosed below which the directors have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial statements have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. The accounting policies that have been adopted in the preparation of this report are as follows

1. (a) Income Tax

By virtue of its aims as set out in the constitution, the Association qualifies as an organisation specifically exempt from income tax the Income Tax Assessment Act 1997.

1. (b) Property, Plant and Equipment (PPE)

Motor Vehicles are carried at cost. All assets are depreciated over their useful lives to the company.

1. (c) Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to balance date

Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs.

1. (d) Provisions

Provisions are recognised when the company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions recognised represent the best estimate of the amounts required to settle the obligation at reporting date

1. (e) Cash and Cash Equivalents

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts

1. (f) Trade Receivables and Other Receivables

Trade receivables and other receivables, including distributions receivable, are recognised at the nominal transaction value without taking into account the time value of money. If required a provision for doubtful has been created

1. (g) Trade Creditors and Other Payables

Trade creditors and other payables, including bank borrowings and distributions payable, are recognised at the nominal transaction value without taking into account the time value of money.

1. (h) Revenue and Other Income

Revenue is measured at the value of the consideration received or receivable..

For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which, for floating rate financial assets, is the rate inherent in the instrument.

Dividend revenue is recognised when the right to receive a dividend has been established.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at reporting date and where outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

All revenue is stated net of the amount of goods and services tax (GST)

1. (i) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables in the balance sheet are shown inclusive of GST.

1. (e) Related Party Transactions

The Committee Members act in an honorary capacity and are not paid for their services as Committee Members.

There were no transactions with related parties during the 2023 year.
